ORDER:-

The Industries & Commerce(Programme-III) Department have issued orders in the G.O. read above for adoption of Food Processing Policy 2015-2020. According to the policy under No.8.6 of the said orders, the Government of Andhra Pradesh will provide 100% exemption of Andhra Pradesh Market Committee Cess/Fees in respect of Procurement of Agriculture/ Horticulture produce directly from farmers by new/existing Food Processing Units. The Industries & Commerce Department has requested to issue orders on exemption of Market cess/ fees to the Food Processing Units from the Agriculture & Cooperation Department.

2. Government, have examined the matter carefully and in exercise of the powers conferred by Section 35 of Andhra Pradesh (Agricultural Produce & Live Stock) Markets Act, 1966 hereby order to exempt 100% from payment of Andhra Pradesh Market Committee Cess/Fees for Procurement of Agriculture/ Horticulture produce directly from the farmers by the new/existing Food Processing Units in the State.

3. This order issues with the concurrence of Finance (FMU(A&C,ACS)) Department, vide their Fin U.O.No.38027/11/FMU(A&CACS)/2016, dated 23-01-2016.

4. The Commissioner & Director of Agricultural Marketing, A.P., Hyderabad shall take further action accordingly.
