ORDER:

The Chief Executive Officer, A.P. Food Processing Society vide letter 2nd read above has stated that the Expert Committee has concurred the demerger proposal of Andhra Pradesh Food Processing Society and communicated a copy of the recommendation of the Expert Committee.

2. In the letter 3rd read above, the Expert Committee has examined the Demerger Proposal in detail and has found it in order and has approved it, and furnished a copy of the approved final Demerger proposal for further necessary action.

3. In the minutes of the meeting of the expert committee held on 15th December, 2016 the Demerger plan of M/s Andhra Pradesh Food Processing Society has been approved by both the Andhra Pradesh Food Processing Society and Telangana State Food Processing Society. The Expert Committee after examining the proposal had sent its recommendations to both Government of Andhra Pradesh and Government of Telangana State on 24-01-2015. The Manager, Andhra Pradesh Food Processing Society informed the Expert Committee that Andhra Pradesh Government had approved the Demerger Plan and it has sent it to Government of Telangana State for its approval. The General Manager, Telangana State Food Processing Society informed to Expert Committee, Telangana State Food Processing Society was registered on 30-05-2014 and that both Societies were functioning independently with two separate Boards. The Manager, Andhra Pradesh Food Processing Society and General Manager, Telangana State Food Processing Society informed Expert Committee that there were no sanctioned posts in the Society as on 02-06-2014. There were no regular/permanent employees in Andhra Pradesh Food Processing Society as on 02-06-2014. In Andhra Pradesh Food Processing Society, the employees are presently working on contract basis. In Telangana State Food Processing Society, the General Manager who is presently working is on deputation from Panchyat Raj Engineering Department, the rest of the staff is working on contract basis. The Expert Committee took note of the above facts and it concurred with the proposal of Andhra Pradesh Food Processing Society and Telangana Food Processing Society. The issue of division of employees of Andhra Pradesh Food Processing Society does not arise. The demerger proposal of Andhra Pradesh Food Processing Society has been examined in detail and the same has been accepted by the Government of Andhra Pradesh.

4. In the letter 4th read above, the Government of Tenangana has also accepted the Demerger proposal of M/s AP Food Processing Society.
