ORDER:

In the reference 2nd read above, Government have constituted State Level Empowered Committee (SLEC) with the officers of different Departments connected to Food Processing Industries / Schemes etc., so that applications under different schemes of National Mission on Food Processing (NMFP) can be sanctioned and a critical review be undertaken periodically for further steps to be taken as per the suggestions made by the State Level Empowered Committee so that there is co-ordinated action in the activities of the departments in obtaining clearances, in achieving systematic implementation and ensuring progress in establishing Food Processing Industry in the State.

2. In the 1st SLEC meeting held on 17/05/2013, under the Chairmanship of Chief Secretary, it was decided to constitute a Screening Committee to suggest and advice the SLEC on adoption of criteria for evaluation of applications received under NMFP and also to suggest the sectors that need to be emphasized and given priority while sanctioning the proposals under NMFP etc.

3. Government, after careful examination, hereby constitute a **Screening Committee** under the Chairmanship of the Special Chief Secretary/ Principal Secretary to Government, Agriculture Department with the following officers as indicated below:

2.	APC & Principal Secretary to Government, Horticulture, Agriculture & Cooperation Department	Member
3.	Special Chief Secretary/ Principal Secretary / Secretary to Government, Finance (FP) Department	Member
4.	Special Chief Secretary/ Principal Secretary / Secretary to Government, Animal Husbandry & Dairy Development, Fisheries Department	Member
5.	Special Chief Secretary/Principal Secretary / Secretary to Government, Panchayat Raj & Rural Development Department.	Member
6.	The Commissioner of Industries, Andhra Pradesh, Hyderabad	Member
7.	Special Chief Secretary / Principal Secretary / Secretary to Government (FP), Industries & Commerce Department and State Mission Director, National Mission on Food Processing	Member / Convenor

4. The functions of the Screening Committee will be as follows:
- I. To suggest to the SLEC, the sectors that need to be emphasized and given priority while sanctioning the proposals under NMFP and guide in the preparation of State Food Processing and District Food Processing Plans.
 - II. To advise the SLEC on adoption of criteria for evaluation of applications received under NMFP. While doing so not more than 15% marks shall be awarded on criteria that require subjective evaluation.
 - III. To suggest the inter se allocation of NMFP funds among the schemes.
 - IV. To suggest SLEC on the cutoff date to be adopted for considering applications received and also
 - a. Whether to consider the applications received from the date of notification of NMFP schemes from 28.8.2012 onwards or to consider only those applications received after issue of the advertisement, and suggest a suitable solution.
 - b. Whether to consider 7.2.2013 as the final date for receipt of applications as mentioned in the press advertisement.
 - V. To suggest to the SLEC on the adoption of the guidelines of NMFP and procedures to be followed for release of funds in instalments to sanctioned applicants.
 - VI. To suggest to the SLEC monitoring, reviewing and evaluation mechanisms, including development of an e-Tool for monitoring for effective implementation of NMFP in the State.
 - VII. To suggest to the SLEC, the level competent to accord project specific approval under all components of NMFP and the delegation of sanction powers of the SLEC to the Screening Committee or a Sub-Committee of SLEC.
 - VIII. To scrutinise the individual proposals received and recommend the proposals to SLEC for sanction and release of funds

The Screening Committee shall meet at the earliest and can meet as often as required thereafter.
