**Sub: Change of name& contact details w.r.t.empanelled PMC under mega food parks**

Dear Sir

We refer to the list of empanelled Project Management Consultants (PMCs) for Mega Food Parks and Integrated Food Parks Schemes of Govt of AP, as mentioned in your website.

We would like to inform you that IL&FS Cluster Development Initiative Limited (ICDI), which is listed as the PMC at S. No. 1, was earlier our wholly subsidiary. As part of a resolution process in IL&FS Group, undertaken by the Board of IL&FS Ltd appointed by Govt of India, and overseen by the Government of India, Ministry of Corporate Affairs, we have acquired the business undertaking of ICDI on a slump sale basis, and thus this business undertaking is now a division of Schoolnet, called as Cluster Development Initiative (CDI). The entire manpower, professional staff and other credentials / empanelment / approvals from Govt of India and other agencies which were issued to ICDI, are now transferred to Schoolnet.

The Ministry of Food Processing Industries (MoFPI), Govt of India, has approved the novation of all rights, obligations and claims of ICDI under all its contracts to Schoolnet, vide circular

dated 24.9.2020, copy of which is enclosed for your reference. Accordingly, Schoolnet is now acting as PMC under the mega food parks scheme of MoFPI.


